
Budget & Staffing

The Sheriff's Office is the primary law enforcement agency in the county. Our other responsibilities include transporting inmates/prisoners to and from jails, prisons and our courts: serving court documents and writs to county residents; staffing the courts with security personnel when court is in session; and dispatching all calls for emergency services (Sheriff, State Police, Fire, Rescue, Animal Control, Conservation Police, etc.) in Goochland.

The Sheriff's Office is funded by both the State and the County. In late 2009, Governor Kane substantially reduced sheriffs' budgets. The reduction here resulted in the loss of one law enforcement position. That position has not been re-instated.

The Auditors have broken down the Office budget into four categories: Sheriff-Court Related, Sheriff, Emergency Services (Dispatch), and Correction and Detention (the per diem fee paid to Henrico county Jail and James River Juvenile Detention for the keeping of adult and juvenile inmates).


Due to our small size, we cross train. Six of our deputies started as dispatchers, and occasionally, they help out in the Communications Center when there is a manpower shortage. Three of our deputies are trained in hostage/crisis negotiations; eight volunteer to be a part of our tactical Rescue Team. One investigator is trained to analyze computer components on our F.R.E.D. (Forensic Recovery electronic Device) computer.

In addition, we have many deputies who have other specialties (canine, language interpretation, firearms instruction, etc.)

Significant Events 2011

Feb 2: Brenda Grubbs Arrest

Goochland Sheriff Jim Agnew arrested Goochland County Treasurer Brenda S. Grubbs for embezzlement.

On January 24, Wachovia Bank investigators contacted the Sheriff Office to report unusual bank transactions with a county account. Deputies and the Sheriff referred the investigator to county officials and requested that the State Police investigate the matter.

The Sheriff's Office became involved with the investigation after Goochland County Administrator Rebecca Dickson called to report that Grubbs had attempted to withdraw \$14,000 in cash from a county account.

Virginia law requires the Attorney General's approval before State Police may investigate a constitutional officer. That approval had not yet been granted, and in order to ensure the integrity of the county financial system and to prevent any further attempts to withdraw cash, Sheriff Agnew arrested Grubbs for embezzlement after interviewing her.

The investigation uncovered more than \$180,000 in county money that had been taken with the majority sent overseas to Nigerian scammers.

Feb 19: **Wildfires**

Goochland's deputies and dispatchers were busy again the weekend of February 19. Dispatch took in 330 different calls for service and deputies spent much of Saturday assisting fire and rescue as they fought brush fires. The largest, on Cardwell Road, consumed about 100 acres and involved dozens of firefighters. Extra deputies were called in to help and off duty dispatchers responded to the Sheriff's Office to help with radio and telephone traffic.

Normal activity did not cease as a result of the fire, however. Deputies arrested four people for DUI. One arrest came after a short but hi-speed chase up Cardwell Rd near the fire scene. The driver attempted to hide in a driveway but was apprehended by Deputy Chris Jones. The driver was charged with DUI, Possession of Marijuana, and Felony Eluding.

March 7: **Goochland Man Found Dead; Roommate Arrested**

Goochland sheriff's deputies arrested a Manakin-Sabot man early on the morning of March 7 after a Chesterfield man called the Sheriff's Office to ask that deputies check on the welfare of his friend.


At 9:30 pm March 6, deputies responded to a home in the 12900 block of Holly Lane in Manakin-Sabot and spoke to a man later identified as Andrew McKenzie. Deputies were checking on the welfare of Eric Amman after Amman's friend called from Chesterfield saying that he was worried about Amman.

Deputies inquired about Amman's health and McKenzie responded by saying that he didn't know what the deputies were talking about. As deputies were verifying McKenzie's identification, McKenzie closed the door and refused to allow deputies to enter. McKenzie then called 911 and requested an ambulance for Amman saying that Amman was bleeding from the nose.

Moments later, McKenzie placed Amman on a wheeled office chair and pushed it to the front door which he then opened for deputies. Amman was bleeding from the nose and he was unresponsive. Deputies began CPR until Goochland Fire and Rescue units arrived. CPR efforts were not successful and Rescue units pronounced him dead at 10:20 pm.

While attempting to revive Amman, deputies noticed drug paraphernalia in the room. Deputies then obtained a search warrant for the residence. During the search, deputies confiscated 145 marijuana plants of varying size, numerous pipes and other smoking devices, syringes, pills, grow lights, scales, baggies, a razor blade with residue, and a jar of what appeared to be mushrooms.

Deputies arrested McKenzie and charged him with Manufacturing Marijuana.



March 28: **Goochland H. S. Student Submits Winning Entry**

Evelyn “Brett” Alvis of Goochland High School designed and submitted this year's winning Metro Richmond Crime Stoppers poster. One poster from each participating jurisdiction (Richmond, Henrico, Hanover, Goochland, New Kent, and Charles City) was submitted and Evelyn's was selected as the winner. April 19: **Crozier Store Robbed**

On April 19th, 2011 at approximately 2011 hours, a man wearing a green t-shirt, blue jeans, and dark colored shoes entered the Taylor's Country Market located at 1535 River Road West (Route 6) in Crozier. The suspect walked up to the counter and displayed what appeared to be a hand gun wrapped in a white paper towel. The suspect demanded the money from the cash register and then fled the store on foot with an unknown amount of cash.

Thanks to help from local media, the man was later identified as Michael Wayne Duncan, 37, of Gum Spring. Duncan was arrested for Armed Robbery and firearms charges by Goochland Rescue Team members the following morning. He was later charged with a similar robbery in Chesterfield County.



April 27: **Tornadoes Touch Down in Goochland**

According to The National Weather Service, a tornado with estimated winds of 86 to 110 mph moved along a two-mile path in eastern Goochland and western Hanover counties Wednesday about 8:25 p.m. another funnel cloud touched down just west of Goochland Courthouse. Fortunately, damage was minimal.

April 30 & October 29: **Drug Take Back Days**

On 4/30 Goochland deputies turned over 102.4 pounds of prescription drugs to the DEA at the culmination of Drug Take Back Day. On October 29, residents turned in 21 pounds of drugs to deputies. Deputies were stationed at Companies 3, 5, and 6 as part of this nationwide initiative.

August 4: **Man Arrested for Bogus Timber Deal**

Deputies obtained warrants for William Roland Massey III for after Massey attempted to harvest timber from large tracts in western Goochland. He was charged with Obtaining Money by False Pretenses.

August 23: **Earthquake Strikes Goochland**

Dispatchers fielded hundreds of 911 calls after a 5.8 magnitude earthquake struck Central Virginia. Numerous homes in the western portion of Goochland were damaged and homes in other parts of the county sustained broken items as a result of the shaking. Fortunately, no one was injured during the quake.

Deputies responded to Goochland High School where they assisted in the evacuation of students from the buildings.

Aug 27: **Tropical Storm Irene**

On the heels of the earthquake, deputies and dispatchers fielded hundreds of calls from citizens after Tropical Storm Irene hit the county. Damage was minimal though deputies responded to more than 50 calls for downed trees. Extra Sheriff's personnel manned the EOC throughout the night and into the next morning in the event that an emergency was declared.

One person was arrested for Driving under the Influence after he attempted to drive around a tree that was blocking traffic on Route 6 in Manakin. Deputies were standing by at the tree with flares and flashing lights when the driver ignored their order to stop. Fortunately, the driver did not strike the tree or the deputies.

Sept 9: **Marijuana Eradication**

On September 9, 2011 the Goochland County Sheriff's Office and Virginia State Police executed a search warrant at a residence in the 2400 block of Hidden Hollow Lane. The address is located in the central portion of Goochland County off of Dogtown Rd. 21 marijuana plants being cultivated in various locations around the residence were seized. These plants ranged from 2.5ft to 4ft in height.

38 year old Daniel Lee Spartichino of Goochland County was arrested on a felony charge of Possession with intent to distribute marijuana.



November 16: **Arrests made in residential B&E**

On 11/16/11, the Goochland Sheriff's Office made three arrests in a residential B&E that occurred on Log Cabin Road just off of Maidens Road around 2:30 PM. The suspects made entry into the home and were scared off by a resident.

As the suspects fled the scene, the resident was able to obtain a good description of the suspects and their vehicle. The witness notified the Goochland Sheriff's Office immediately and deputies were in the area within minutes. A deputy spotted the vehicle on Maidens Road near Route 6 and a traffic stop was conducted on Route 6.

The individuals were identified as David Anthony Davis, 27, of Richmond, Cody Justin Graham, 28, of Henrico, and Charity Ann Allen, 20, of Dundas. All three individuals were placed under arrest without incident and are charged with Breaking and Entering and Possession of Burglar{ Tools.

December 10: **Unknown Car Thief Identified by Caller and Is Arrested**

Goochland deputies sought the help of local news media after a man attempted to steal a car in eastern Goochland. All three local Television outlets broadcast a picture of the subject and within hours, he was positively identified.

The man attempting to steal a vehicle from a VDOT Park and Ride was identified by a television news viewer. Tony Bernard Martin, 44, whose last known address is Fort Defiance in Augusta County was being sought by the Goochland Sheriff's Office for Grand Larceny.

Martin attempted to steal a vehicle at the Ashland Road Park and Ride adjacent to I 64 early on the afternoon of December 10. A friend of the vehicle owner spotted Martin who claimed to be from a vehicle repair company. The friend managed to take a digital photo of Martin who then fled on foot across I 64 after the friend called 911. Early on the afternoon of December 11, a caller identified Martin after seeing the photograph on a television newscast. Ironically, the caller stated that Martin had just been released from Riverside Regional Jail in Hopewell at 10 am December 10. Goochland deputies confirmed this with the jail and later recovered the clothing Martin had been wearing upon his release from the jail near the crime scene.

Augusta County Sheriff's deputies arrested Martin on December 12.



December 11: **Group Distributes Racist Literature**

During the evening hours of December 11, anonymous persons left racist materials in the yards and driveways of central Goochland residents. Many residents called the Sheriff's Office to complain.

A group called the Knights of the Southern Cross Soldiers of the Ku Klux Klan of Powhatan claimed responsibility.

Deputies advised residents to throw the unwanted fliers into the trash.

December 20: **Kwamane Davis Sentenced for September 2010 Killing**

Kwamane Davis, 21, was sentenced in Goochland Circuit Court for the September "Baby Shower" killing on Hadensville-Fife Road. In that incident, Duane Hardy, 24, of Goochland was killed by a shotgun blast to the head.

A 23 year old Goochland man suffered permanent paralysis from a gunshot wound and a 54 Goochland man was shot in the buttocks during the incident.

December 15-23:

New 911 Equipment Installed

New digital 911 equipment was installed in the Sheriff's Office to replace the obsolete switching equipment that had been in place for more than twenty years. The new equipment allows dispatchers to answer and transfer calls more efficiently.

Community Concerns

Bicycles and Motorists

The sheriff received quite a few complaints about bicyclists riding on county roads. Some of the complaints were from motorists and some were from cyclists themselves. The sheriff instructed deputies to strictly enforce laws related to cycling.

Both motorists and Cyclists called the Sheriff's Office with concerns regarding the increasing conflicts between cyclists and automobiles. In response to a representative from the cycling community, Sheriff Agnew met with about 25 cyclists at the Goochland Library on September 28.

Agnew went over Virginia law relating to bicyclists and explained the reason for tickets issued to cyclists at West Creek. He also reiterated the danger of using Goochland's crowded and shoulder-less roads for riding.

WWBT 12 covered the meeting that lasted about 1 ½ hours.

Traffic Controls

In response to several complaints and concerns regarding the lack of traffic controls at the intersection of Broad Street Road and Manakin Road, the Sheriff joined other county officials in requesting that a light be installed at the intersection. After an original denial, VDOT agreed to place the light at the completion for the widening of Broad Street Road.

Revised Speed limits

In an August 22 Email to VDOT, Sheriff Agnew objected to the raising of the speed limit on Blair Road from 35 mph to 40 mph. He cited citizen concerns and the frequent use of the road by Collegiate, St. Catherine's, and Benedictine students as the reason for not raising the speed limit.

Removal of the Treasurer

At the request of the Attorney General and the Goochland board of Supervisors and on behalf of the citizens of Goochland, on February 10, the Sheriff Wrote Governor Bob McDonnell requesting the ouster of Treasurer Brenda Grubbs.

Suspicious Persons


One of the most frequent complaints from citizens to dispatch was, once again, a request to check on a suspicious person or vehicle. Deputies responded to 1201 requests to check suspicious circumstances.

Residential Break-Ins

The sheriff sent out Email warnings to residents urging them to call the Sheriff's Office with any persons or vehicles they deemed to be suspicious. The Email was in response to several burglaries throughout the county.



All Calls for Service to Dispatch 2008-2011





* In September 2008, the new, more accurate RMS/CAD system became operational and resulted in an increase of call reporting


Calls for Service for Fire & Rescue 2008-2011


Sheriff Calls by Day of Week 2011


Rescue Calls by Day of Week 2011

Agency: GVRs Date: 01/01/2011 - 12/31/2011




Fire Calls by Day of Week 2011

Agency: GCFR Date: 01/01/2011 - 12/31/2011




Sheriff Calls by Hour of Day 2011


Rescue Calls by Hour of Day 2011


Fire Calls by Hour of Day 2011


Fire Calls by Station 2011


Calls by Fire Station






Calls for Traffic Accidents by Day of Week 2011


