The Goochland County Electoral Board convened at 9:01 am in the Director of Elections' conference room. Present: Chair Keith Flannagan, Vice Chair Wanda Taylor, Secretary Robin Lind, Director of Elections Frances Ragland, and Republican Party Chair John Myers.

The board proceeded to canvass the results of the election of November 8, 2016, accepting 16 of 17 provisional votes; the results of which are hereby included in these minutes.

The Chair complimented the Director of Elections and her staff for "making a tough job look easy."

On a motion of the vice chair, seconded by the chair, the board voted unanimously to adopt a policy that no new Officer of Election be assigned as an Electronic Poll Book operator without being accompanied by an experienced senior Officer.

The Vice Chair also recommended that training should emphasize that the Statements of Results must NOT be signed by Officers of Election until after close of polls and completion of statement.

The board agreed to set its next meeting for November 28 at 8 am; there being no further business the board voted unanimously to adjourn at 1:49 pm.
