Thank you for your interest in participating in the Mentoring/Internship and Volunteer Program (MVP) through Goochland County Parks, Recreation & Facilities! Enclosed you will find all of the materials needed to apply to be a Department Volunteer.

Please fill out the application form and return it to the Recreation Division offices as soon as possible. The Recreation Division offices are located at the Goochland Sports Complex (the old high school).

**Applicant Timeline:**

Applications will be reviewed on a bi-monthly basis (every even month).

Applicants must be a minimum of 13 years of age by January 1<sup>st</sup>, 2014. Volunteers, who successfully complete the MVP program and receive an acceptable evaluation, are eligible to be considered for future volunteer opportunities and potentially for employment with Goochland County in following years.

The Volunteer Program is designed for those youth who are in or have completed middle school. It is intended to be a leadership and workforce development program for young people preparing them to become potential Recreation Assistants or Recreation Aides for Parks, Recreation & Facilities in the future.

The Mentoring/Internship Program is designed for those youth who are in high school. It is intended to be a leadership and workforce development program for young people offering them 'real world' experience in the recreation field. After the mentor/internship period is over, applicants have the potential to become Recreation Assistants or Recreation Aides for Parks, Recreation & Facilities. This program also qualifies for the community service portion of the Goochland High School Senior Project.

Specific details related to the MVP program including overall job requirements, volunteer times, and specific areas of interest can be addressed by Recreation Division staff.
