The Goochland County Electoral Board met on multiple occasions in preparation for the November election, and following to ascertain results, including:

- Officer of Election Training, conducted by individual members on October 20, 21 and 22.
- Logic & Accuracy testing for new DS-200 vote tabulators on October 26
- Officer of Election Training October 27
- Chiefs and Assistants Training October 29
- Electronic Poll Book programming November 1
- Polling place setup preparation November 2
- Circuit riding to inspect polling places on Election Day, November 30, 2020

The board met at 9 am November 4 to canvass results and consider provisional and Drop Box Absentee ballots delivered to the precincts on election day, with advice and research by the Registrar:

Fife: three ballots accepted, one rejected
 Hadensville: five ballots accepted, two rejected
 Three Square: one accepted, none rejected
 Sandy Hook: two accepted, one rejected with regret
 Court House 1: one accepted, none rejected
 Court House 2: none accepted, none rejected
 Shallowell: two accepted, none rejected
 Centerville: five accepted, one rejected with regret
 Manakin: 10 accepted, three rejected, one void
 Blair: seven accepted, three rejected

At 4:03 pm the board adjourned until 1 pm Friday November 6.

At 1 pm November 6, the Central Absentee Precinct officers still engaged in completing their tally, the board stood at ease until reconvening at 3:40 to complete its canvass. The board accepted five ballots and rejected one which was cast by a voter determined to be a Henrico resident.

Final results being ascertained, the board voted to adjourn at 4:38 pm. A copy of the results are hereby included in these minutes.
