

Goochland County Electoral Board
Minutes, June 9-11, 2021

The Goochland County Electoral Board convened at 9:03 am, June 9, in Room 270 in the County Administration Building to Canvass the results of the Democratic Primary election held on June 8.. Present: Chair Keith Flannagan, Vice Chair Wanda Taylor, Secretary Robin Lind and Director of Elections/General Registrar Ryan Mulligan.

At 10:50 the Secretary moved to recess the canvass until 12:30 on Friday, June 11 to complete the results with late-arriving mail-in absentee ballots, seconded by the Chair and adopted unanimously.

The secretary moved to open the provisional canvass and immediately recess until Friday June 11, seconded by the vice chair and adopted unanimously.

The board reconvened on Friday, June 11 at 12:35 pm. Present: Chair Keith Flannagan, Vice Chair Wanda Taylor, Secretary Robin Lind and Director of Elections/General Registrar Ryan Mulligan.

While the board waited on the Central Absentee Precinct officers to complete their canvass discussion ensued about Handicap Accessibility at the new polling place proposed as a replacement for Fife Firehouse in District One. The board asked the Director of Elections to contact the Schools Superintendent to enquire about possible use of Byrd Elementary School is ADA Compliance cannot be achieved at the other location,

The board asked the director of elections for his recommendation on the single provisional ballot which had been cast. He recommended rejection on the basis of improper registration. On a motion by the vice chair, seconded by the secretary, the ballot was rejected unanimously.

The board then received the results of the CAP precinct and completed the canvass of results, which are appended to these minutes.

Discussion then ensued on the issue of candidate signature petitions and the director of elections described an apparent error in a candidate petition for the position of school board member on the November 2 Special Election. An appeal is anticipated.

There being no further business, on a motion by the vice chair, seconded by the chair, the board voted unanimously to adjourn at 1:55
