

Goochland County Electoral Board  
Minutes October 11, 2022

The Goochland County Electoral Board was called to order at 6:04pm. Present: Chair Pamela Johnson, Vice Chair Robin Lind, Secretary Wanda Taylor and Director of Elections/General Registrar Ryan Mulligan. Also present were Goochland residents: Charlotte Whitmire, Emma Lalumandier and Susan Lascolette

Emma Lalumandier inquired about access to voting software information. The Director of Elections/General Registrar reiterated that he do not have access to the requested information. Mrs. Lalumandier was instructed to follow the process of contacting the Clerk's office to request the information. Charlotte Whitmire informed the board about an observation she experienced as a poll worker where a voter was being told they could not vote and that they needed to bring their ballot back.

On a motion by the Vice Chair, seconded by the Secretary, the minutes of September 13<sup>th</sup> meeting were approved as printed with correction.

The Director of Elections/General Registrar submitted the latest voter registration counts. There are 20,393 active voters in the county. The board reviewed the registration count by locality, the 743 inactive count and discussed the impact of the changes to precincts and to the Officers of Election polling locations assignment. The Director of Elections/General Registrar also stated that the sheriff will participate in the chief training.

The Director of Elections/General Registrar presented the Electoral Board with nine names for approval as Officers of Elections. The Vice Chair moved that the Board accept the names as presented by the Director of Elections subject to being found fit and approval by the Precinct Chief and the General Registrar. The Secretary seconded the motion. Approved unanimously.

The Director of Elections/General Registrar reported on the preparation for Election as follows:

- He stated that he had contacted Mr. Drumwright with confirmation about the placements of the voting signs.
- He confirmed that the Sherriff is aware of new polling locations and have assigned the deputies.
- He explained the New Poll book process and informed the board that the new EPB software be loaded on Sunday 11/6 @ 7am
- He stated that the Officer of Election Training will occur on 11/3 & 11/4 at 10am, 2pm and 6pm in room 270
- He stated that the Chief and Assistant Chief training will be on 10/25 & 10/27 at 10am, 2pm & 6pm and again on 11/2 at 6pm in room 250
- He also stated that he was pleased with Shannon and Leigh-Anne stating that they were coming along nicely.

Unfinish business, the Director of Elections/General Registrar reported that they are currently processing the 330 voter changes they received from the DMV Hopper.

There being no further business, on a motion by the Chair and seconded by the Vice Chair the board voted unanimously to adjourned at 7:30pm.
