Minutes December 9, 2025

The Goochland County Electoral Board was called to order at 9:10am. Present: Chair Bob Walker, Secretary Wanda Taylor, Director of Elections /General Registrar Ryan Mulligan. Also, present was Valerie Morris. Vice Chair was not Present.

Citizen Comments: none

Approval of Minutes: The board approved the meeting minutes for November 5th, 10th, 12th & 13th on a motion by the Secretary and seconded by the Chair. The motion carried.

Report of the Director of Elections/General Registrar:

1. *Registration Counts: The Director of Elections/General Registrar stated that:*
 - a. *Registration Counts: The Director of Elections/General Registrar submitted the latest voter registration counts. There are 23,861 active voters and 519 inactive voters in the county.*
 - b. *The board reviewed the registration count by precinct and reiterated the urgency to create new precincts due to the growth in 402-Centerville and 502-Blair. It is the board's position to make recommendations to the Board of Supervisors.*
 - c. *A meeting will be arranged between Director of Elections/General Registrar and the Tuckahoe Pines Administrator.*
2. *Appointment of Officers of Elections: (closed session if needed)*
 - a. *The board requested the Director of Elections/General Registrar to send an email to Party chair to remind them to submit the OOE list.*
3. *Report on In-Person Absentee Voting and the General Election*
 - a. *The board agreed to order 115% ballots again next year.*
 - b. *It is possible that Goochland had the highest percentage of votes cast in Virginia. 71%*
4. *Any Additional items General Registrar may have*
 - a. *The Director of Elections/General Registrar stated that he met with Dr. Raley about the budget and the possibility of increasing the space to house, perform L&A and having enough room for individuals to observe.*

- b. He also discussed redistricting, printing and the impact on the budget.
- 5. Hotwash has been scheduled for December 16th at 6pm.
