

Budget Process –Ongoing!

- Listening to residents is ongoing
- Formal Process started early October 2023
- November 2023 through January 2024:
 - Met with all County Departments
 - Met with all Constitutional Officer Departments
 - Met with Schools to review needs and requests
 - Held work sessions with Schools, County Departments, and Constitutional Officer Departments for Five-Year CIP
 - Met with Board Members to establish priorities



Budget Priorities

- Consistent with Board Strategic Plan
- Conservative approach to revenue projections and expenditure growth
- Seek efficiencies and cost savings where possible
- Expand public safety service levels
- Meet or exceed all Financial Policy requirements
- Maintain competitive employee compensation with neighboring jurisdictions
- Support operations through expanded positions when possible
- Self-sustaining rates for utilities

Budget Process –All Revenue Sources

- Throughout the budget process County staff forecast available revenue to fund the proposed budget

 - Charges for Services / Fees
 - Grants

Long-Term Budget Impacts



- Impact of inflation
- Potential recession
- Continued desire from community for increased public safety
- Growing community and aging population – increased calls for service
- Public education funding from the Commonwealth and local needs
- Constantly increasing health insurance costs
- Need to maintain competitive employee salaries and benefits
- General assembly legislation and possible local mandates



FY2025 25-Year Capital Improvement Plan (CIP)



Summary of FY2025 Budget Accomplishments

- Continues to meet or exceed all financial policies
- Includes 5% cost of living salary increases for all County employees
- Public safety remains a priority – 16 new full-time positions funded, additional 5% salary increase for sheriff and fire-rescue personnel
- Education remains a priority - \$2.12 million increase in local contribution, \$1.24 million in school CIP projects
- Includes funding for necessary studies for upcoming projects for the community
- No increase in real estate tax rate, TCSD tax rate, or personal property tax rate

Document Shredding

- Secure document shredding is available for up to five bankers boxes (no larger than 12" x 24") per person.
- Paper clips and staples do not have to be removed, but plastic binding must be removed.

Household Hazardous Waste Collection

- Acceptable items include:
 - Fluorescent tubes and bulbs (CFLs)
 - Solvents, degreasers, and cleaners
 - Flammable liquids
 - Pesticides and herbicides
 - Aerosols
 - Art and hobby supplies
 - Photographic chemicals;
 - Pool and spa chemicals, thermometers and other mercury containing devices.
- While supplies last, Limited disposal quantities available.

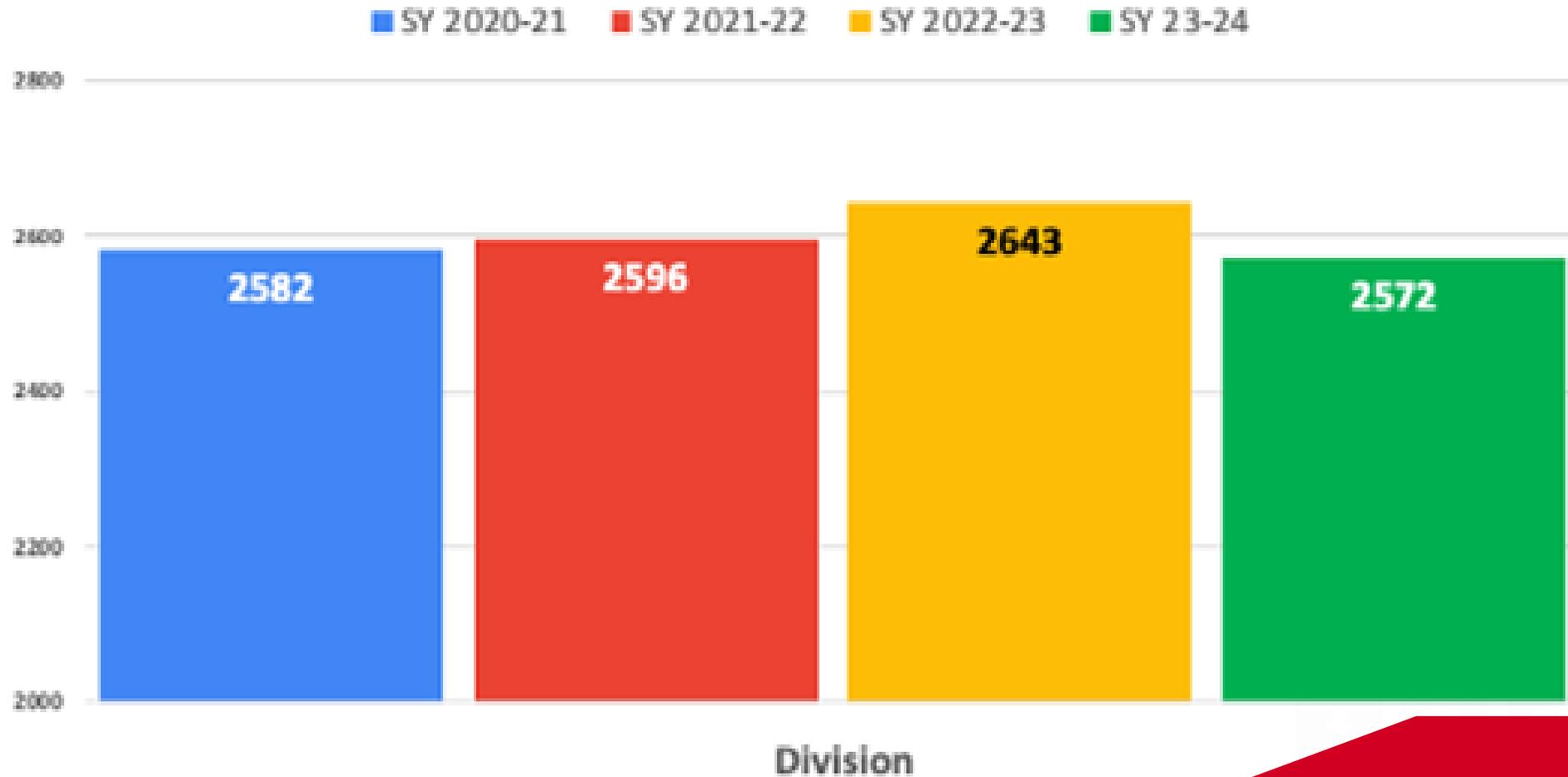

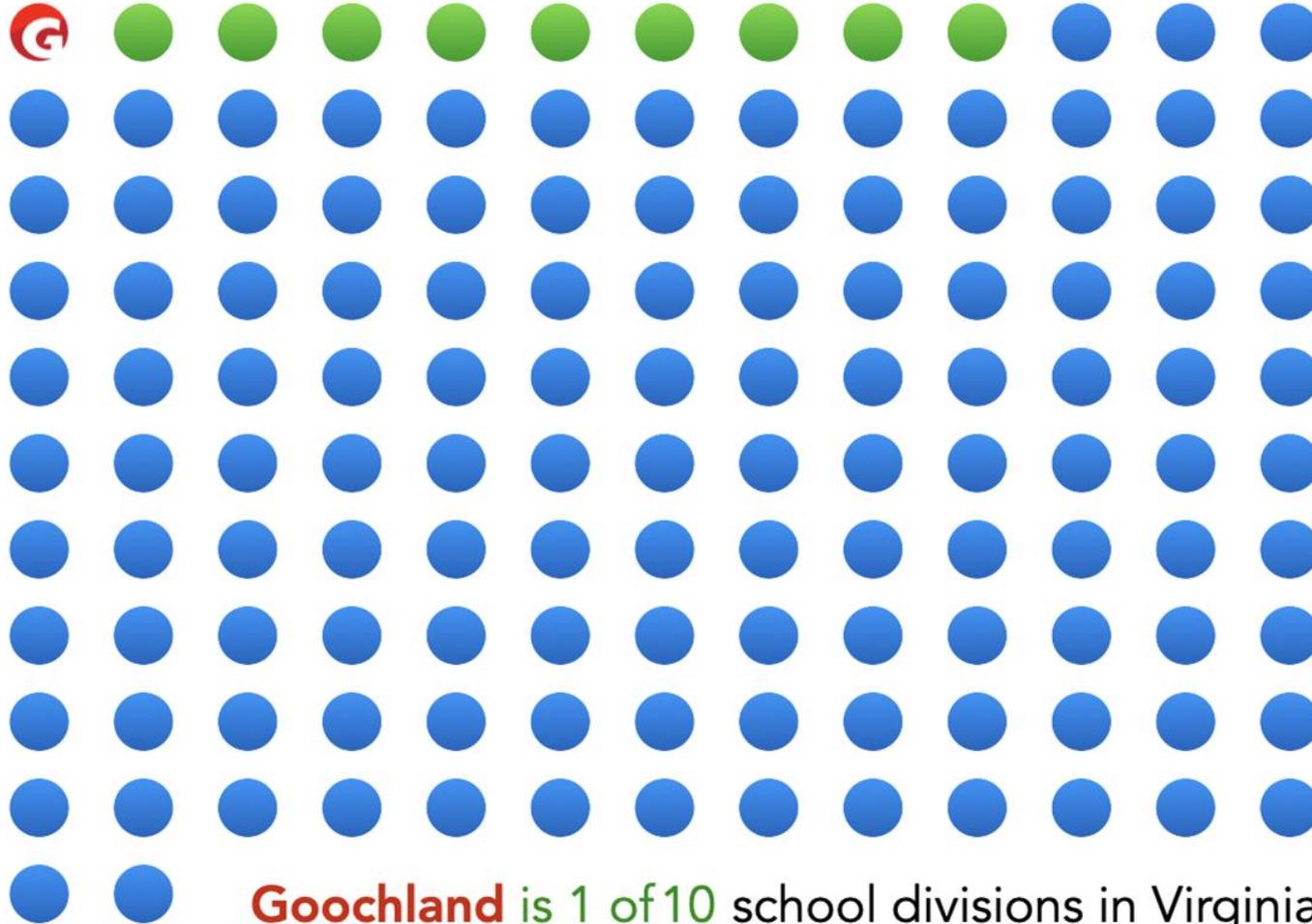



■ Percentage of Students Who Met/Exceeded Projected Growth Goal



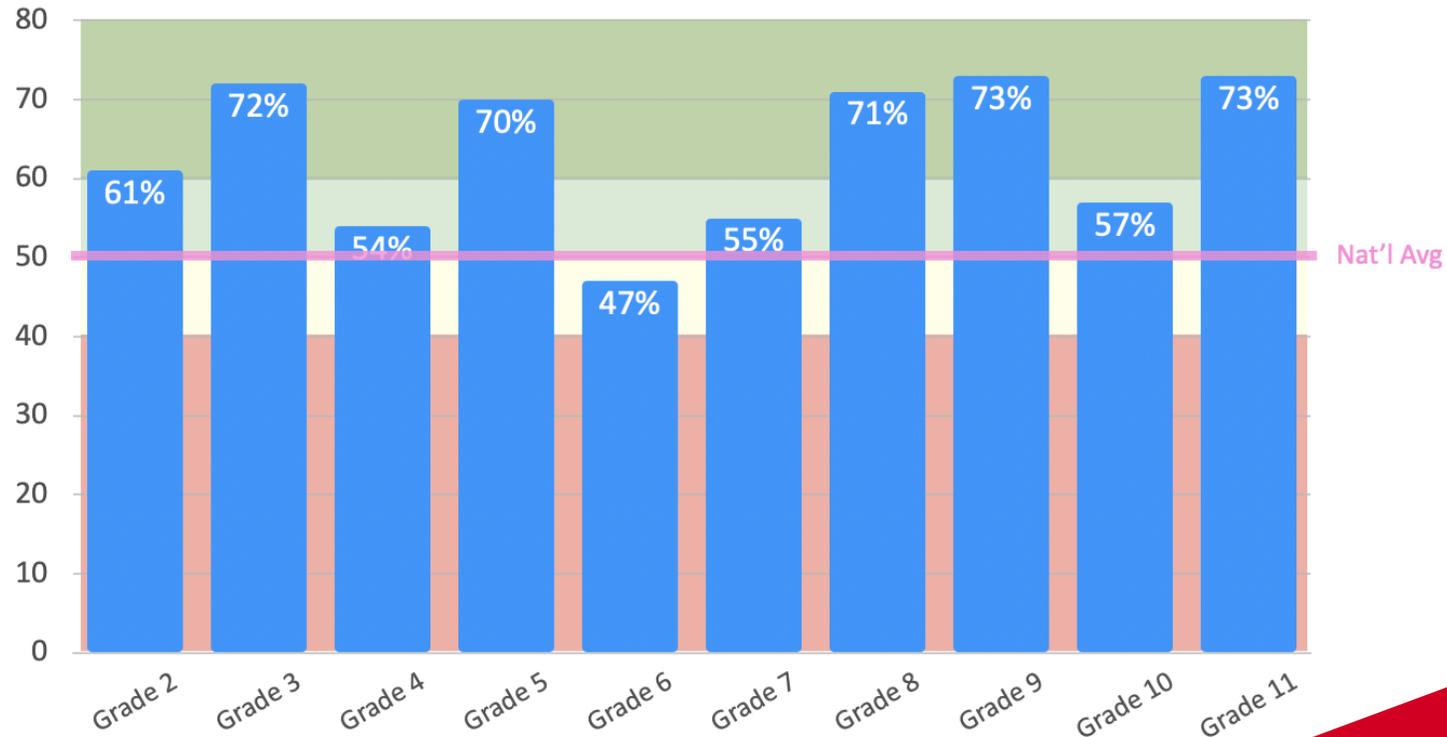

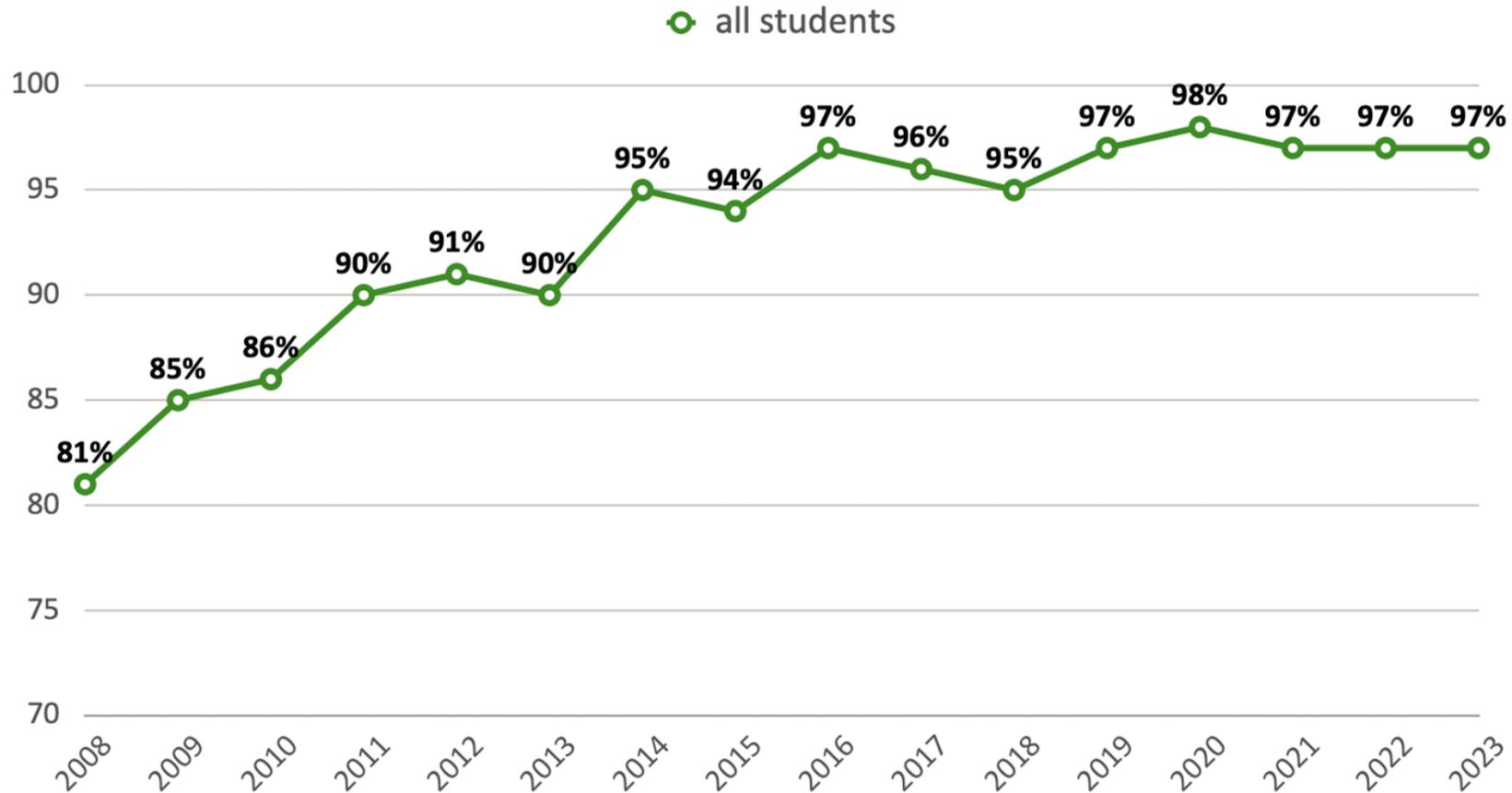



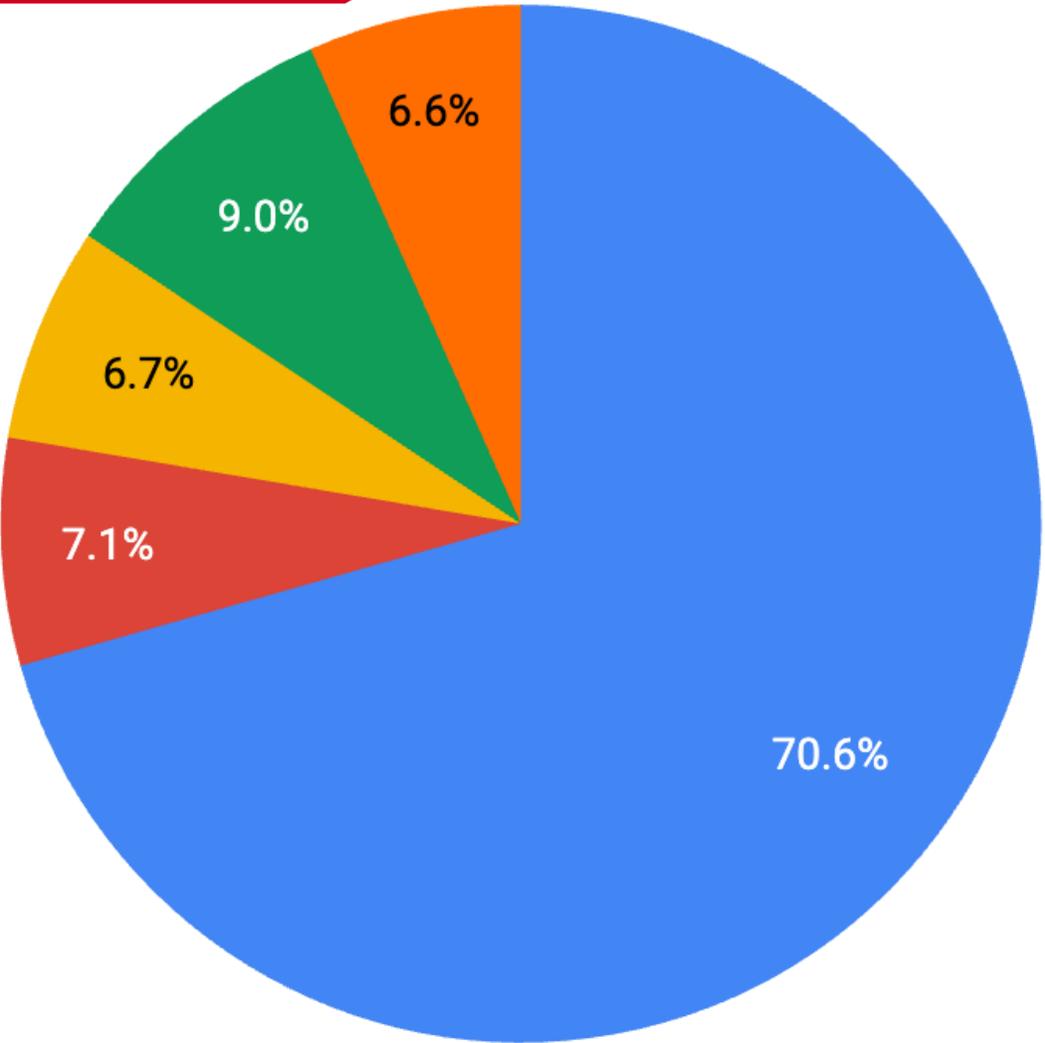

Proposed GCPS FY25 Budget Investments (By State Category)

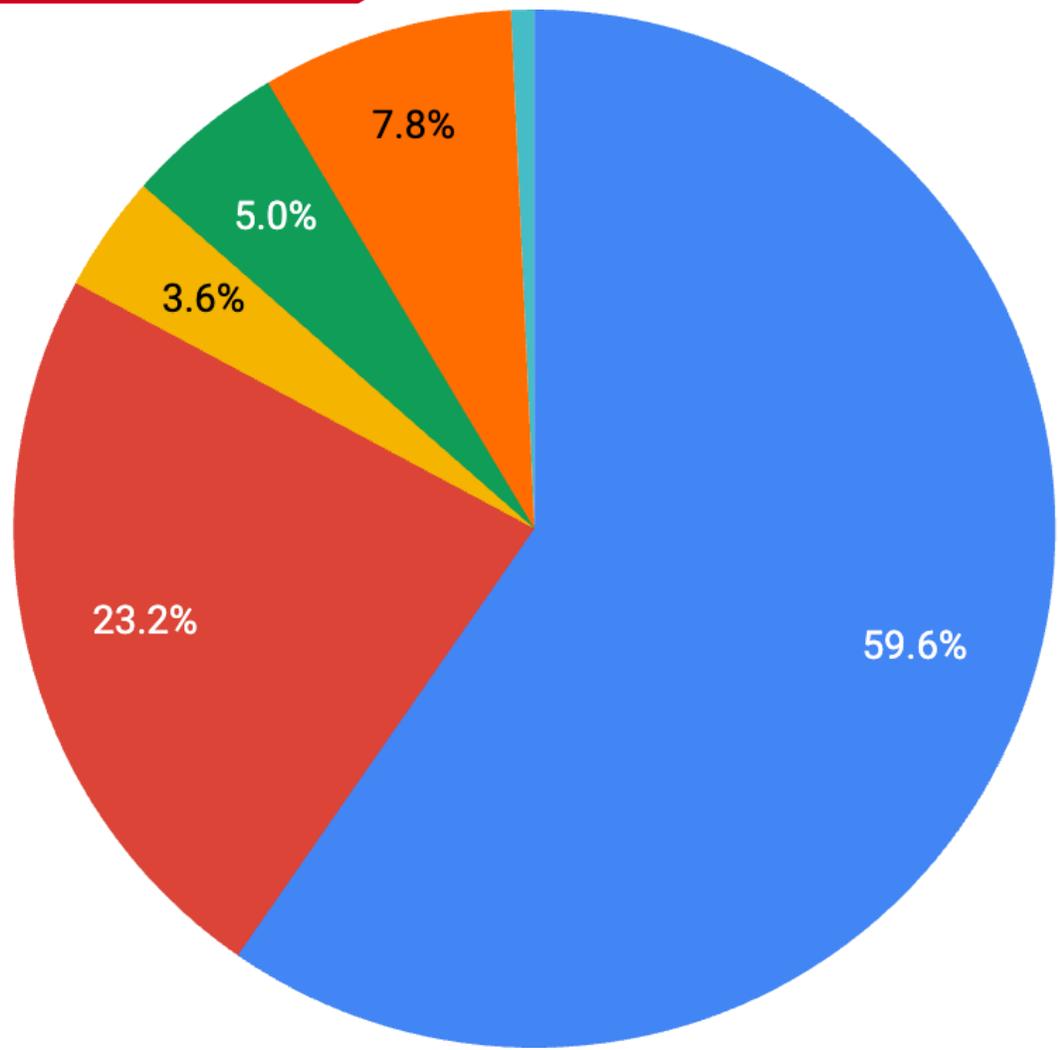




Funding Sources FY25

FY 2025 Operating Revenue Budget



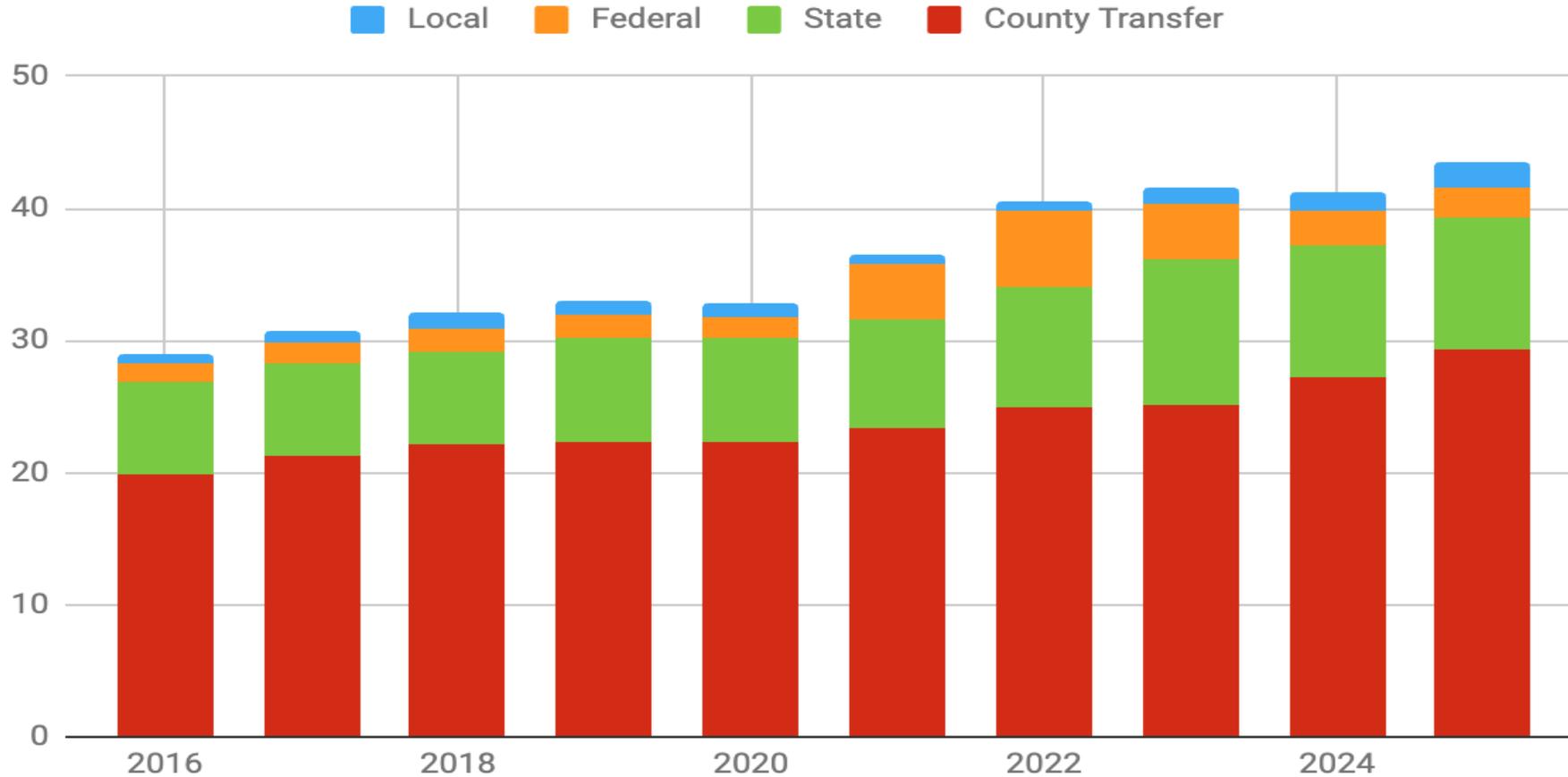

- **Market adjustment pool for teachers (to be at median or in top half of competitive regional divisions) \$1.4M**
- More funding for new textbooks based on Virginia Literacy Act and new math SOQ standards
- Three additional interventionists or reading specialists- one per elementary school
- Secondary SPED teachers (Middle & High) to reduce caseloads
- Filling the gap on deferred maintenance and vehicle replacements because of less CIP funding this year \$1M

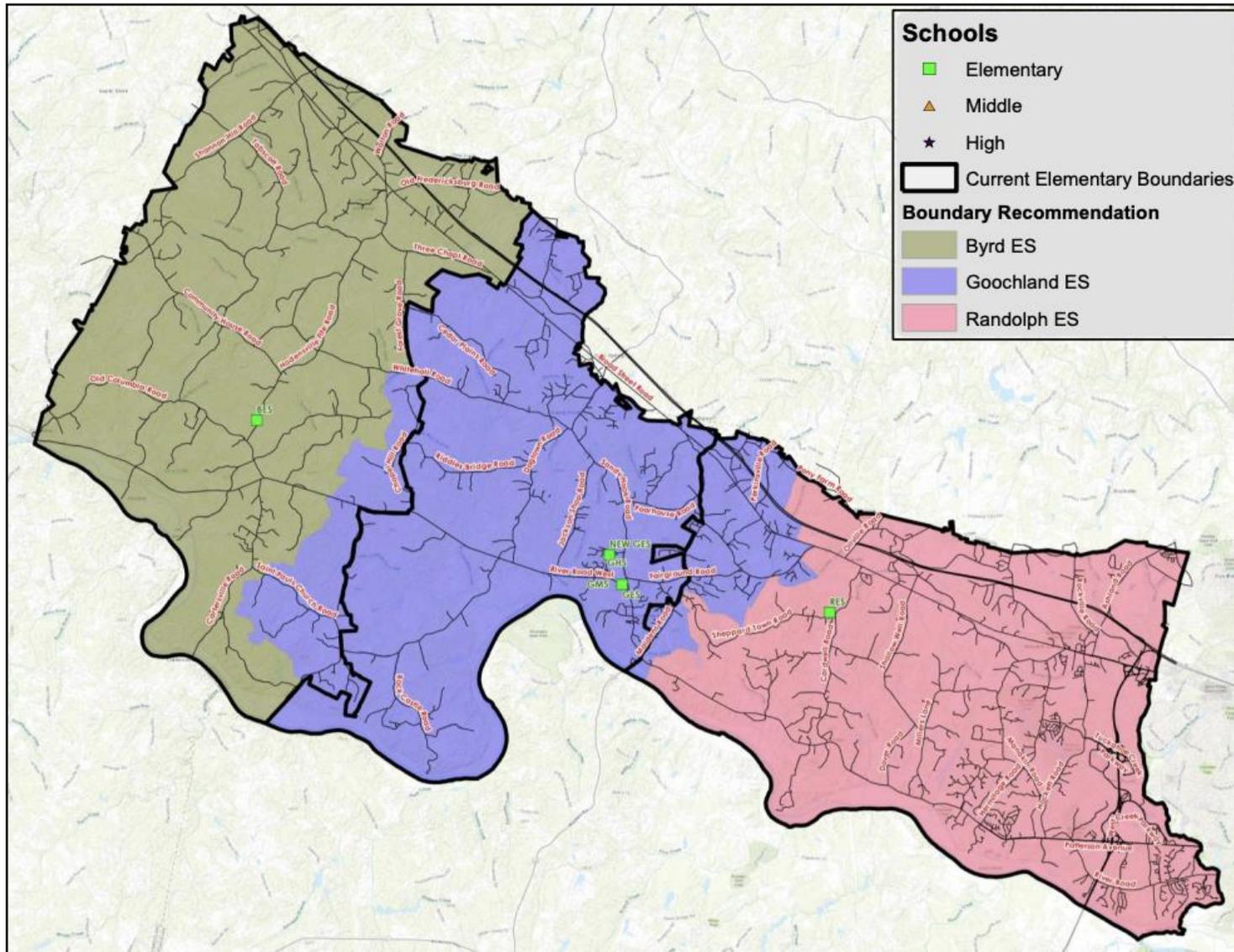

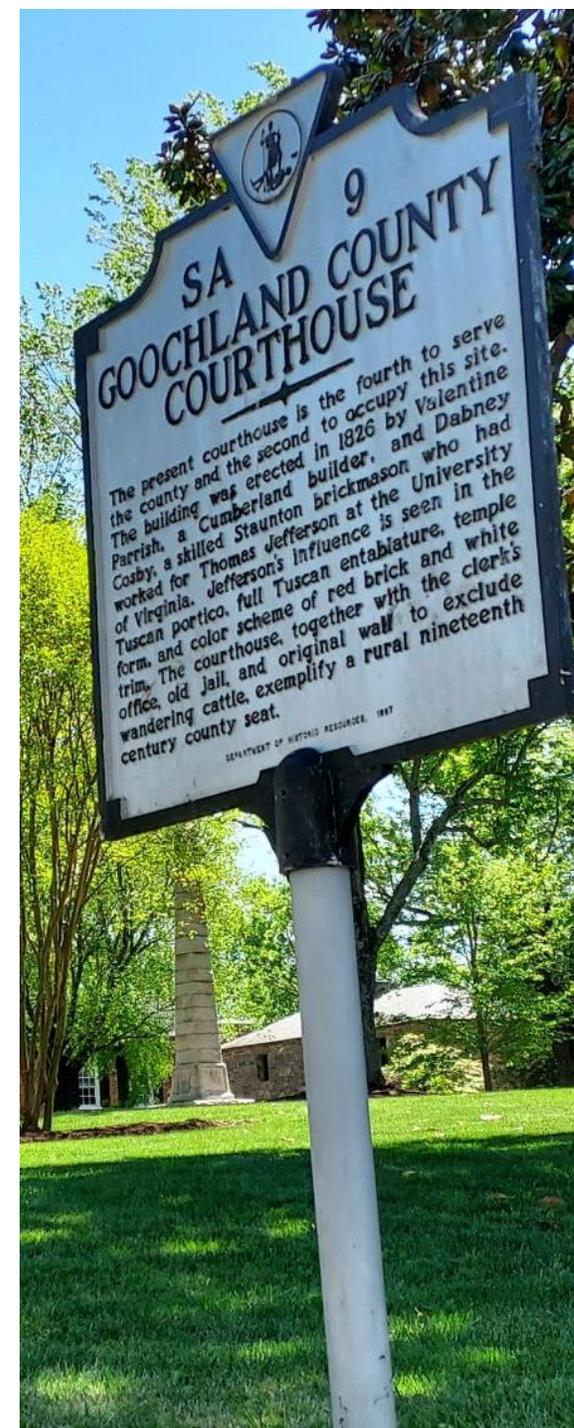

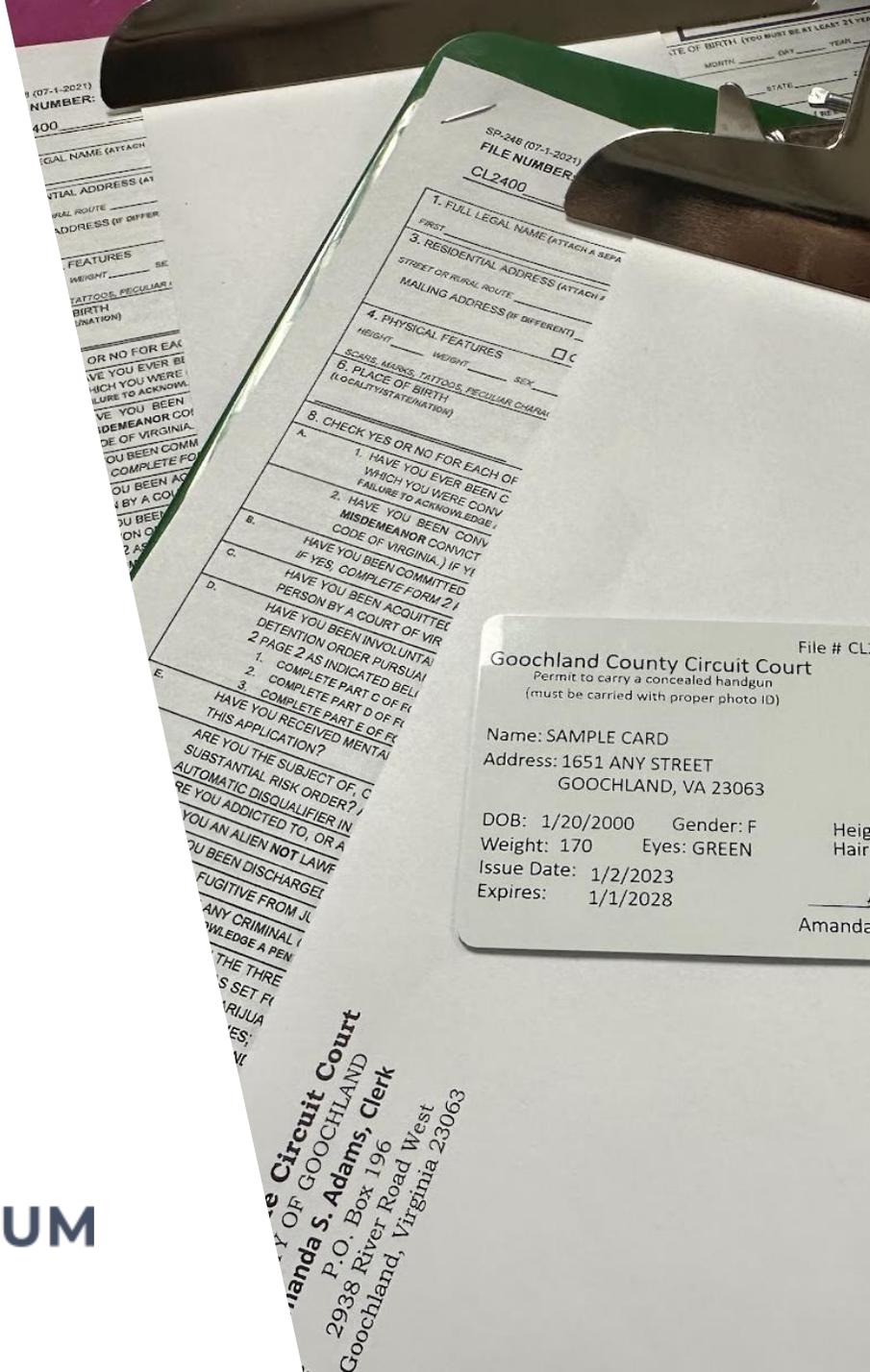
