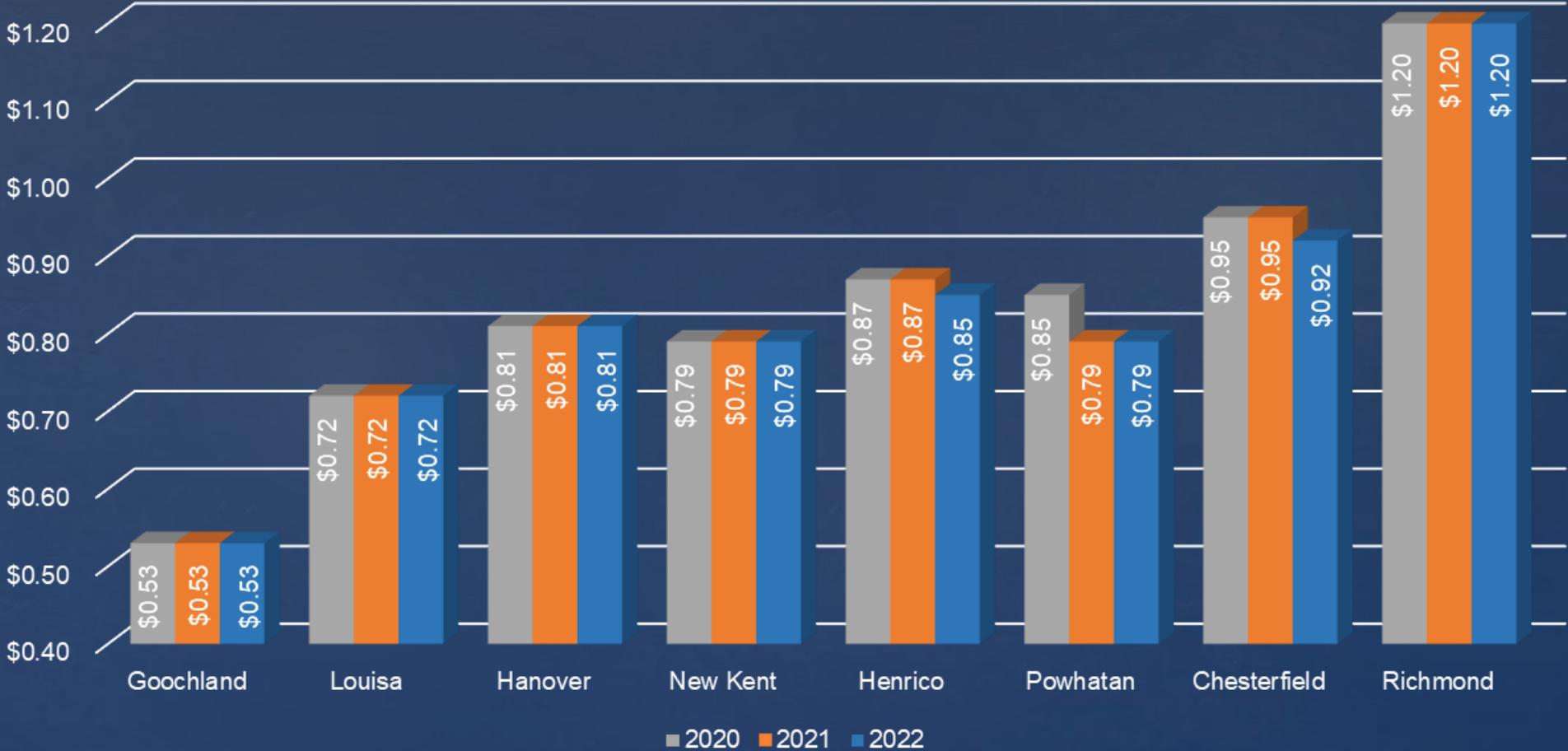

FY 2023 Proposed Budget Highlights

- Goochland's economy remains strong
- FY2023 budget continues to meet or exceed all financial policies
- Public safety and education remain the priorities in the FY2023 budget
- Significant investments in the CIP are included in this budget
- No increase in real estate tax rate or TCSD tax rate in FY2023 budget
- FY2023 budget includes 3% merit raises for County employees and market comparison increases


CY2022 Real Estate Tax Rates



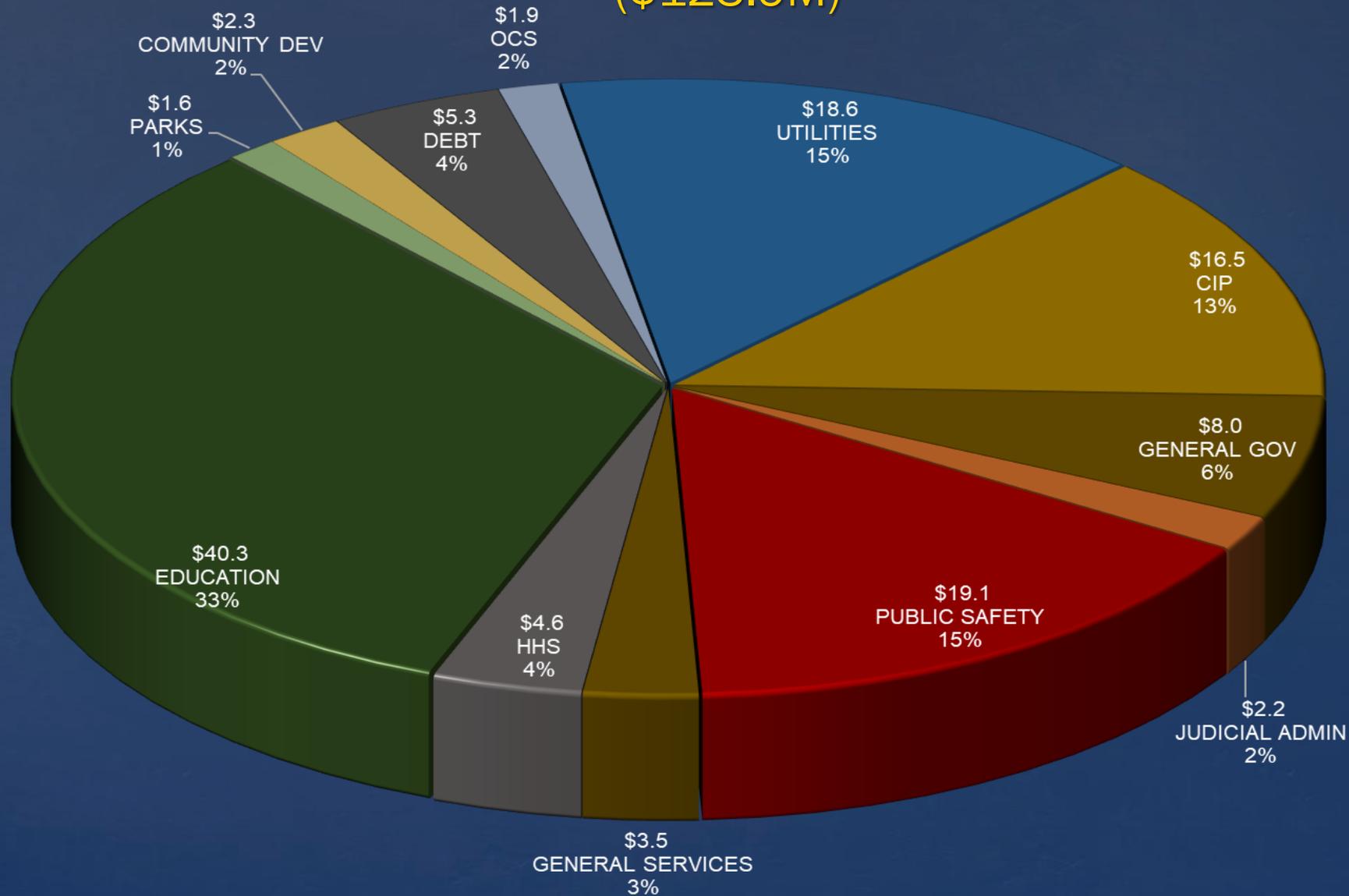
No Real Estate Tax Increase Proposed for CY2022




FY2023 Proposed All Funds Revenue Budget (\$123.9M)



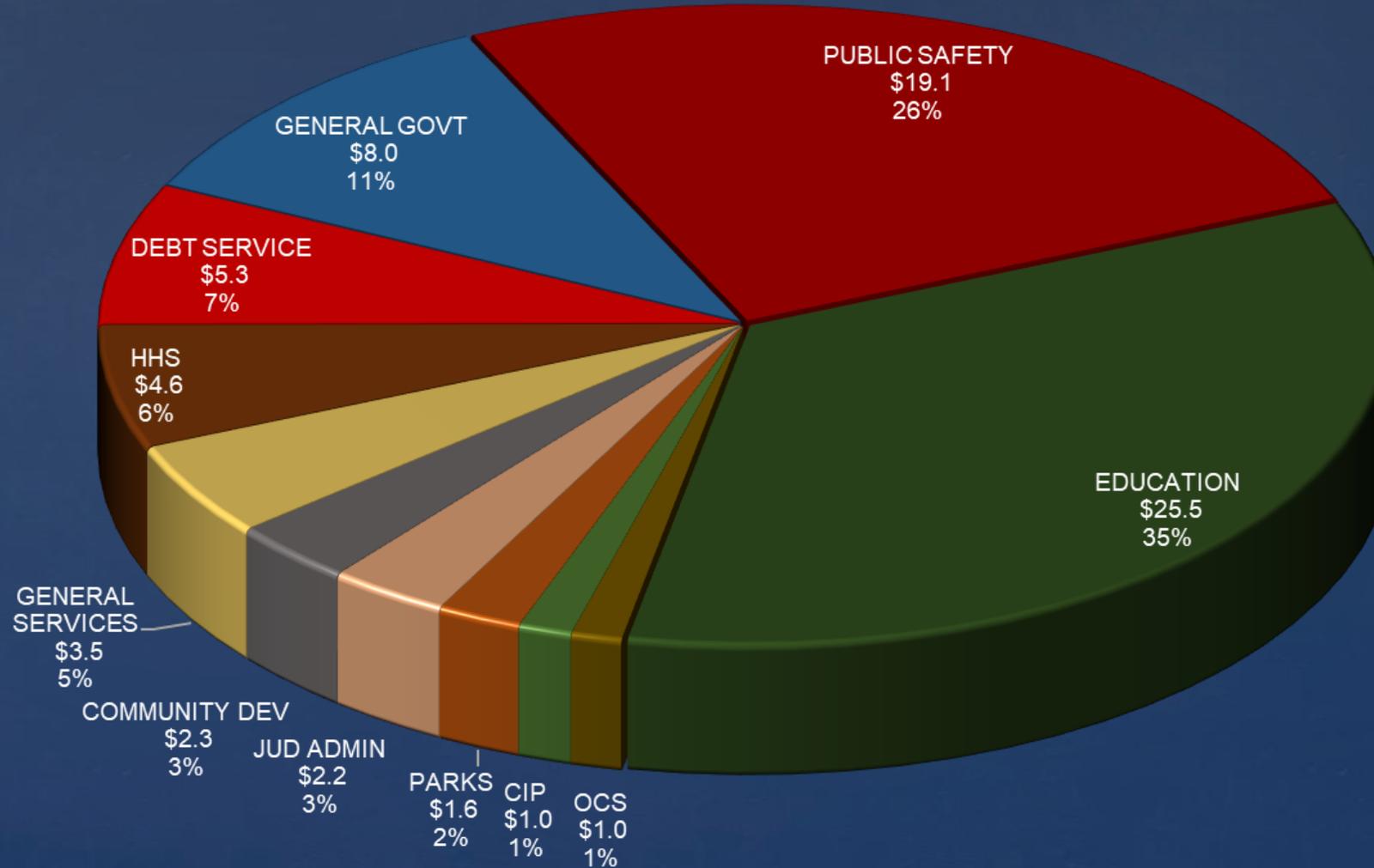
FY2023 Proposed All Funds Expenditure Budget (\$123.9M)




Debt Service to Total General Government Expenses

- Public Education – 4.0% Funding Increase, up \$1.0M to \$25.5M

 - Major Renovations to Middle and High schools
 - GES funded in FY22 CIP

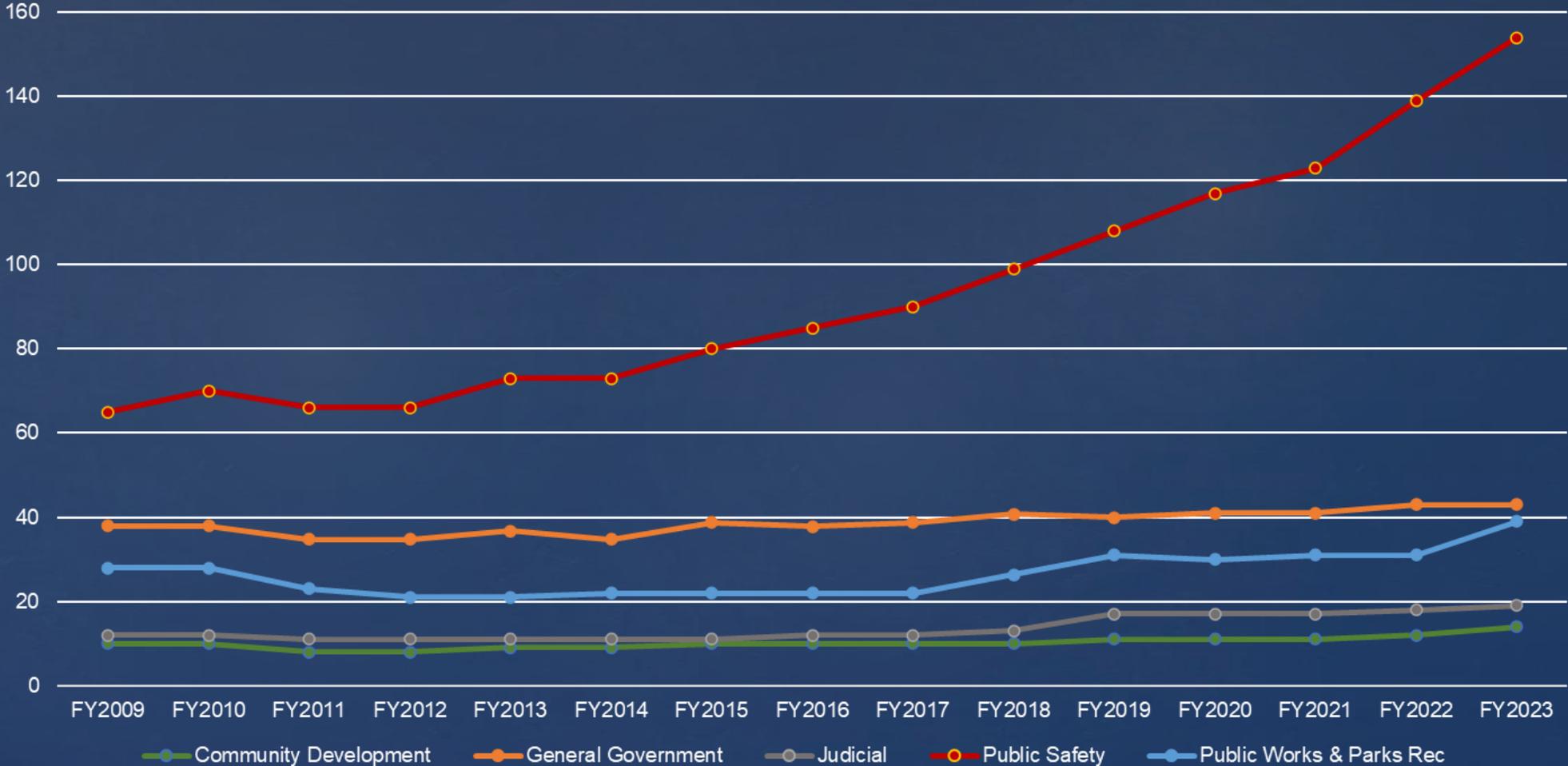





Department of Public Utilities - Revenues




Ad Valorem Rate Versus TCSD Assessed Values

Challenges and Opportunities




- Future budgets may not be able to rely on the growth in assessments

GVA Bond Referendum Update



Voters overwhelmingly passed two bond referendum questions on November 2, 2021 ballot to allow the county to issue General Obligation Bonds for schools, fire-rescue, and courthouse construction projects.

GVA Bond Issuance

For the first time, Goochland County issued General Obligation Bonds on our own in February 2022 without any support or going through Virginia Resources Authority (VRA).

- Triple AAA from S&P, Moody's, & Fitch and voters approval made it possible
- Issued \$50 Million in Bonds
- Funds new Goochland Elementary School & West Creek Fire-Rescue Station construction

Firefly Broadband Announcement 11/10/21

Port 80 Internet VATI

- Port 80 has completed 17 Miles of fiber backbone
- They are now in the process of site surveys and customer installations

Firefly Fiber Broadband

- Firefly is extending fiber to CVEC customers in the Shannon Hill and Hadensville areas
- CVEC customers in that area should have service by the beginning of summer at the latest, they should sign up now at www.fireflyva.us.
- Beginning work on USDA ReConnect grant. That includes Poorhouse Road and Turner Road areas













Proposed GCPS FY 2023 Budget Investments (By State Category)






Funding Sources FY 2023

FY2023 Operating Revenue Budget




- State Sales Tax (10.9%)





Elementary School Boundary Adjustment






Boundary Considerations (all to the greatest degree possible):


- Keep neighborhoods intact

Balanced Calendar 2.0 for 2023-2024



Highlights

- IF approved, this calendar would be effective for the 2023-2024 school year, allowing our families and staff ample time to plan for this change
- OPTIONAL intercessions for both students and staff
- Potential for 23 additional instructional days
- One week intersession in October, versus two weeks
- Starting the school year two weeks earlier than our current calendar. This provides for a one-week break in October and two-week break in March/April for those who choose.
- Remote learning day on Election Day in 2023
- Opportunities for professional work days for teachers throughout the year
- Work day for teachers prior to the winter break in 2023
