Once again, as Zoom made it impossible to see the pointer, I am not exactly sure of what was said. But if you are proposing diverting traffic onto Saddlecreek Parkway, that is a horrible idea. 7/15/2022	First, before the meeting we had reviewed the multi-modal recommendations posted on the website and found them right on the money: sidewalks, crosswalks and bike facilities in the right places and to the right effect. Second, we like very much the concepts offered during the meeting on village branding (particularly the gateway signage) and landscape architecture (particularly the greenways and larger, treed setbacks and backyard parking along main roads - too bad that the Residence Inn by RT 288 didn't get that message.) However, the architect's sketches and conceptual plats seemed to promote more commercial density than we'd like in the core Village (almost shoulder-to-shoulder, three-story, street corner-to-street corner). Overall, we'd like the Village to project an appearance and walkability like a smaller-scale Innsbrook development, which also could inform the target businesses for the economic development areas: (smaller) office campuses and entertainment venues, such as music venues or theatres, gyms, bowling alleys, tennis courts and ball fields, etc. connected by walkable trails.  One of the biggest challenges we see is facilitating pedestrian crossing of Rt250 within the Village. Perhaps larger Rt 250 medians, with shaded resting points (trees and benches or shelters) would encourage crossing walkers to stop mid-street. The idea of traffic rotaries seems out-of-touch with the current rush hour traffic backups and the need for safe, pedestrian-only crossing periods. We were told at that time this area would soon have water and sewer and would be one of 2 areas that Goochland County would concentrate on for its future development. Adjacent to our south is approximately 24 acres which has been classified as Manakin Town Center, it has zoning for 50% residential, 30% commercial and 20% open space and has received approval to develop 234 residential units. After 25 years that land is still sitting vacant.  As such we have always believed, that Manakin Town Center and Sycamore Creek should be developed and classified as one, a village concept. A concept that would incorporate retail, residential, commercial and maybe a hotel or health care facility.  Over the years we have had many developers look at and even submit plans for development of Sycamore Creek only to be shut out by the very small density available that is detrimental to their development. Now 30 years later, we certainly believe that this area of Goochland County is ripe for development and strongly believe that a density given to Sycamore Creek should be at least equal to that allotted to Manakin Town Center. This could bring in a higher class of developers such as East West partners to create a great plan for the county that would incorporate both pieces of land.  Finally, we would be very interested in the time frame the county has in mind for whatever transpires for the Centerville Village Community.
